

MESSAGE OF THE INTERIM COUNTRY DIRECTOR

Violence against women and girls is termed as a "Shadow Pandemic," the causes and effects of which remain hidden in many societies. The stigma associated with it means that mentioning it in public is seen as shameful, and reporting it is deemed as against societal norms. This has also tenaciously affected the way in which women and girls can access justice in the country where millions lack understanding and awareness of their fundamental rights. In turn, it has serious consequences in exacerbating Gender-Based Violence against women and girls, who are silenced from reporting incidences to local law enforcement agencies and have inadequate awareness about the Protection Mechanisms. The few that are able to access remedial services are often met with complicated, timely and costly legal procedures that could act as a deterrent to finding immediate support and protection. When close family members are involved in violence and abuse, this becomes even more challenging.

Undoubtedly, it is a long journey towards an equal and non-discriminatory society where women and girls are treated with utmost reverence for their capabilities and are given the space and agency to make their own decisions. Surrounded by frequent abuse, violence and unequal treatment, the safe spaces for women are shrinking; with many finding their own homes to be unsafe, including in Pakistan.

Pakistan is amongst the countries that have ratified international treaties and optional protocols for the peace, fulfillment and equality for women and children. Despite signing these treaties and having new and existing laws and policies in place, Pakistan still ranks in the lowest rungs of the ladder when it comes to gender equality.

Recently, Oxfam's project titled "Creating Spaces to Take Action on Violence against Women and Girls," provided us with an opportunity to develop a resource directory of Essential Services operating in Sindh, that provide an immediate response, shelter and legal aid to survivors. The directory maps out the contact information of essential services that are available and functional in various districts of Sindh, including but not limited to hospitals, police stations, shelter homes and crisis centres, legal aid services, NGOs and helplines of government institutions. In addition, those helplines of federal institutions that are applicable to provinces are also documented for easy access.

Oxfam in Pakistan acknowledges and appreciates the support of Legal Aid Society in helping us map and document relevant information for this booklet, to allow for greater ease in understanding and dissemination. We extend our gratitude to Sindh Commission on the Status of Women, who assisted us in realising the need for a referral document, and for taking up the responsibility of updating the information as necessary going forward. This directory will be used as a resource for all our communities and institutions, to ensure that information pertaining to essential services is easily accessible to all citizens in the province.





MESSAGE OF THE CHAIRPERSON

Sindh Commission on the Status of Women (SCSW) commends the effort of Legal Aid Society and Oxfam to develop a referral directory for the survivors of sexual violence. When the commission started working and monitoring the situation of Gender-Based Violence in Sindh, it emerged that there are several institutions at government and non-governmental level but most of them operate without linkages. Therefore, several cases have not been properly handled due to gaps in knowledge and understanding regarding where the survivors of violence can go for relief and which institutions they should link up with. After monitoring the situation, the SCSW discussed the need for a referral directory for survivors of sexual violence with Oxfam in Pakistan and the Legal Aid Society.

This directory will be critical to assist survivors of violence in emergency situations. It will not only enable the survivors themselves to reach out to the appropriate services available but will also enable institutions working to combat Gender-Based Violence to provide immediate relief to survivors through stronger institutional linkages.

I am thankful to the Legal Aid Society and Oxfam in Pakistan for developing this important document. The SCSW hopes that this directory will prove to be another leap forward for the provision of timely support for survivors of violence and that it contributes towards bringing an end to GBV in the province of Sindh at large.

MESSAGE OF THE CHAIRPERSON

Access to justice for women and girls has remained a multi-faceted issue with social and cultural challenges that limit their mobility and capacity to access essential services. Women are often unable to travel to courts or police stations on their own. There are deeply entrenched notions of shame and stigma attached to being a victim of sexual and gender-based violence and victims are expected to accept such treatment or face social ostracism. Women are less able to navigate the formal justice system than their male counterparts. Low literacy and lack of legal literacy make women and girls less aware of their rights and as a result, less able to access them. The lack of an effective legal aid system further compounds the distraught situation of victims. While several pro-women laws specifically relating to SGBV now exist, their implementation is extremely weak. Many women, once they have reported a case, are particularly vulnerable to violence and are in urgent need of support in terms of shelter, protection, medical care and legal aid. In such cases, there is no system, standard operating procedure or cohesive plan of action to provide them with the support they need.

The Directory of Support Services for Women and Girls Experiencing Violence and Abuse is the result of a collaboration between Oxfam in Pakistan, Sindh Commission on the Status of Women and the Legal Aid Society. The directory is built upon a multipronged approach and is developed on the basis of district level data collection, local knowledge, practices and demands from across Sindh. It is hoped this resource will translate into a sustainable toolkit which will assist service providers in connecting victims and survivors of SGBV with timely and high quality essential services for the protection of their rights and to assist them advance towards accessing and realizing justice.

INTRODUCTION

This resource directory is a product of the project titled "Creating Spaces to Take Action on Violence Against Women and Girls" This project is undertaken with the financial support of the Government of Canada, provided through Global Affairs Canada. The project aims to reduce Violence Against Women and Girls (VAWG) and Child, Early and Forced Marriages (CEFM) and is being implemented across 9 districts of Punjab and Sindh. This directory is a joint product of a collaboration between Oxfam in Pakistan, Legal Aid Society, and the Sindh Commission on the Status of Women (SCSW) and has been developed to support women and girls who have experienced violence by increasing their agency and ability to access the police, shelter homes, medical facilities, legal and psychosocial support services and other essential services in the districts of Dadu, Hyderabad, Matiari, Kambar Shahdadkot, Shaheed Benazirabad and Umerkot in Sindh (hereinafter referred to as 'Selected Districts').

The primary target audience are survivors of VAWG and CEFM, however, the resource directory is also intended to assist stakeholders and partners including key line ministries and departments such as the Women Development Department, Social Welfare Department, commissions such as the Sindh Human Rights Commission, Commissions on the Status of Women, law enforcement agencies, civil society organisations, international and regional organisations and academia, others seeking to improve the quality of and access to coordinated and multi-sectoral services for all women and girls.



USER'S GUIDE


The services listed in this resource directory have been verified by extensive fieldwork and data collection and are deemed as being relevant, accessible, functional and responsive to the immediate needs of survivors of VAWG and CEFM in the Selected Districts. The composition of the services is presented in a concise and user-friendly manner.

Essential service providers are listed through district-wise compartmentalization in the following order: police, hospitals, shelters, legal aid service providers, civil society organisations and other government service providers. Details of addresses, contact/focal persons, telephone numbers and operational hours are listed along with the mention of, where applicable, the existence of referral services and other support mechanisms.

Federal, provincial, and district level helplines are also included.

Color coded legends are used as indications of additional services provided by organisations such as Follow-up Services, Referral Services, Psychosocial Support and Legal Aid Services. The key for the legends is presented on the next page.





Legal Aid Service Providers Government Organisations

Follow-up Services

An organisation/institute that has a follow-up mechanism in place for users to assess the effectiveness of services provided and remain in contact.

Referral Services

An organisation/institute providing referral pathways and linkages to other service providers and organisations for essential services including but not limited to legal aid, shelter and medical services.

Psychosocial Support

An organisation/institute providing direct psychosocial support services which aim to address psychological and social needs of victims and survivors.

Legal Aid Services

An organisation/institute providing direct legal aid and advisory services including legal awareness and legal representation.

INSTITUTIONAL OVERVIEW

The majority of service providers listed in this resource directory provide their services free of cost. All police-related services (police stations, complaint cells, human rights cells, women police stations) are formally free for all citizens, including women. All government hospitals and basic health units provide services either completely free of cost or for token amounts. All government-run as well as private shelters provide free services for women survivors of violence. The free services include lodging, food and other basic services. The only service for which there is some formal payment involved is legal aid. While some organisations offer it completely free of charge, others charge a low-cost amount to cover subsidized lawyer's fee or court costs. Almost all the service providers in Sindh are accessible by public transport, with the exception of some police stations in far flung areas. The few services which lie outside town centers and hence inaccessible by public transport are the NGOs in Hyderabad and Dadu and the safe houses in Dadu and Matiari. Most state run service points in Sindh's districts are accessible through a designated contact point even after working hours. All non-state service providers say one designated person remains available after hours. Most official government provided emergency and complaint services in Sindh state they have instituted formal referral systems, namely the Child Protection Units, District Complaint Cells, Women Complaint Cells, Safe Houses, Police Helplines and Police Stations. Some of the larger NGOs in Sindh have formal referral systems and all other NGOs, community-based organization and activists say that they use informal networks for referrals and use their personal networks to address women's requirements on a case-to-case basis. A purview of services is given for an understanding of the facilities provided by institutions and services for access, protection and referral.



HELPLINES

There are many helpline/referral services set up which women survivors can access. In Sindh:

• The Women Development Department operates a helpline '1094' providing women survivors of violence with instant assistance, legal advice, assessment for medical assistance and referral to other service providers.

• There is also a 24 hour GBV helpline '1098' run by Madadgar, a legal aid NGO, providing in-house assistance as well as a referral service to women survivors of violence, with the same name as the official police helpline service.

• The Government of Sindh's Law Department in collaboration with LAS (Legal Aid Society), also a legal aid NGO, has a toll free helpline called Sindh Legal Advisory Call Center which provides legal advice on both civil and criminal matters and referral service connecting to Darul-Amans and Child Protection Units, '0800-70806'.

• The official police helpline is called Madadgar15, with the '15' number to provide citizens composite services including ambulance and fire brigade services, complaints against police, reporting theft, as well as assistance in all complaints by women and children.

• The Inspector General of Police has a helpline '9110' offering emergency assistance, advice and policing services for all cases, housed in the Central Police Office in Karachi.

• The CPLC – Citizen Police Liason Committee operates a generic UAN helpline '1102' but has a dedicated Women Complaint Cell for registering all crimes women face including domestic violence.

In addition to the helplines and referral services in Sindh, the Federal Ministry of Human Rights has also set up its own helpline, '1099'.



POLICE



The Sindh Police, with manpower exceeding one hundred thousand, has made notable structural changes in its response mechanisms to gender-based violence. The police have formed a special Human Rights Cell and a Women and Child Protection Unit that is connected to Women and Child Protection Cells at the district levels. Complaints are registered on the network and followed through, minimizing the chances of attrition in cases. Women police officers are present in some regular police stations in Hyderabad and in Shaheed Benazirabad. In Matiari, Dadu, and Kambar Shahdadkot, women are present in the Women and Child Protection Cells. The Inspector General of Sindh has introduced a complaints cell and helpline through which citizens can lodge complaints about police excesses, extortion, bribery demands, and tax and illegal actions.

HOSPITALS AND MEDICAL SERVICES

Sindh has a vast network of hospitals and health care facilities including 11 government district headquarter hospitals, 27 major government hospitals in urban centres and rural health centers and basic health units in smaller towns and villages. A cadre of Lady Health Worker (LHWs) was established at the grassroots level in 1994, in order to ensure that health education, reproductive health, vaccination and other communicable diseases, promotion of safe water and sanitation and other dimensions could be made easily accessible to local communities. Victims and survivors of violence against women and gender-based violence can seek treatment at any hospital so long as the same qualifies as an emergency case. However, investigation and police reports for legal casework must be routed through a medico-legal officer. In the context of gender-based violence, medico-legal examinations are primarily carried out at tertiary government hospitals. The Government of Sindh has set up a DNA testing facility in Liaguat University of Medical and Health Sciences in Jamshoro in 2015. A forensic science agency serology laboratory was set up at the Panjwani Centre for Molecular Medicine and Drug Research at the University of Karachi in 2019.

SHELTER HOMES AND CRISIS CENTRES

LEGAL AID SERVICE PROVIDERS

Shelter Homes and Crisis Centers provide temporary arrangements for living for women who are in need. Shelter Homes, commonly referred to as "Darul-Amans" meaning 'abode of peace', have been set up by the government, which offer women three months of stay free of cost, extendable in some circumstances. There are four shelters in Sindh, three of which are run by the Social Welfare Department in Sukkur, Larkana, and Hyderabad, and one in Karachi named Panah, run on the public/private partnership model. Additionally, there are three other privately run shelters in the province, one of which lies in Hyderabad and the remaining two are in Karachi. To deal with urgencies, the Federal Government initiated crisis centers (Shaheed Benazir Crisis Centers for Women) which were intended to house women for 2-3 days to provide assistance in emergencies before moving onto shelters. In Sindh, there are four such crisis centers situated in Karachi, Shaheed Benazirabad, Jacobabad and Hyderabad.

Legal Aid Service Providers refers to organisations/institutes which provide pro bono and/or lo bono legal assistance, advice and representation before courts and administrative forums for resolution of disputes. Legal Aid Committees notified by Bar Councils and Associations in addition to District Legal Empowerment Committees created by the Law and Justice Commission of Pakistan in 2011, remain largely dysfunctional as a result of which the void in service provision is met to some extent by not for profit organisations.

CIVIL SOCIETY ORGANISATIONS




GOVERNMENT ORGANISATIONS

Civil Society in Sindh comprises of schools, universities, advocacy groups, cultural institutions, NGOs and activists, engaged in development and relief initiatives. They have an active role to play in advocacy for improved institutional performance, policy frameworks, and lead innovative initiatives to address impending issues. For instance, Women's Action Forum launched as a pressure group in 1981, works with other Civil Society Organisations to ensure gender equality for women. Numerous Civil Society Organisations also provide free legal advice and services, such as the Sindh Legal Advisory Call Centre (SLACC) helpline managed by Legal Aid Society, Roshni Helpline, Aurat Foundation and War Against Rape (WAR) which work on improving access to justice and empowering marginalised communities. Civil Society has played a critical role in amplifying the range of essential services provided by the State, to combat GBV and improve survivors' access to justice and relevant sexual and reproductive health services.

Government Organisations are important elements of the State machinery setup through legislative or executive action, to administer and oversee specific functions. Government Organisations in Sindh have adopted key international sustainable goals to ensure gender equality and provision of human rights. They have established a number of Women Crisis Centers and Darul-Amans to provide services and protection to survivors and victims of GBV. Sindh Commission on the Status of Women; set up in 2017; also promotes the social, economic, political and legal development of women by focusing on legislative and policy initiatives. The Government of Sindh also has a dedicated Women Development Department that focuses on women empowerment and gender equality by managing Women Crisis Centres in Karachi, Hyderabad, Shaheed Benazirabad and Jacobabad. Due to progressive governments, Sindh, compared to other provinces has a more facilitating environment for gender specific legislation. Notable achievements include laws such as the Domestic Violence (Prevention and Protection) Bill 2013, Sindh Child Marriage Restraint Act (2014).

METHODOLOGY & LIMITATIONS

LAS developed a data form to map and collect information from police stations, hospitals, health care centres, shelters homes, legal aid service providers, civil society organisations and government organisations working on Gender and Sexual Based Violence, Early Child Marriages and Forced Marriages in Selected Districts. Staff from the LAS visited each institution/organisation for on-site observations and assessments before inclusion in the directory. The visits were conducted prior to the outbreak of COVID-19 during the months of February and March 2020. In person data collection was suspended at the end of March 2020 due to the pandemic, which is the reason for limited data for relevant government organisations in Dadu, legal aid providers in Kamber Shahdadkot and civil society organisations in Matiari.
